AGMASOL PT ODOURLESS HIGH FLASH POINT SOLVENT CLEANER IMPREGNATED ONTO NON-WOVEN, LOW-LINTING WIPES.

EACH DISPENSER CONTAINS 300 LARGE HEAVY-DUTY WIPES.

THE WIPE HAS BEEN CAREFULLY SELECTED TO MEET DEMANDING INDUSTRIAL REQUIREMENTS AND IS VIRTUALLY INDESTRUCTABLE UNDER CONDITIONS OF USE BY HAND.

INSIDE THE CONTAINER THE IMPREGNATED WIPES ARE HERMETICALLY SEALED INSIDE A FOIL BAG TO PREVENT IMPREGNANT LOSS PRIOR TO FIRST USE. THE IMPREGNATED WIPES ARE SELF-DISPENSING ONCE THE INNER FOIL BAG IS OPENED AND THE FIRST CLOTH HAS BEEN DRAWN FROM THE CENTRE OF THE ROLL AND FED THROUGH THE OPENING IN THE LID.

RE-CLOSE THE FLIP CAP AFTER EXRACTING A WIPE IN ORDER TO MINIMISE EVAPORATION OF THE IMPREGNANT.

OVERALL PACK SIZE AND WEIGHT HAVE BEEN SELECTED TO PERMIT EASE OF HANDLING AND PORTABILITY.
